Atalaya Mining plc ("Atalaya") are firmly committed to the responsible production of metals throughout our value chain. Based on our experience and knowledge of the business, we strive to achieve the best results with a positive impact on employees, partners, local communities, the environment and all our stakeholders.

To achieve this, we are committed to the sustainable management of our operations by acting in a manner consistent with our values and policies, through environmental, social and governance performance set out in the following pillars that make up our Atalaya Sustainability Policy:

#### I. Good governance and responsible management

- Ensure a system of good corporate governance according with our Code of Business Conduct and Ethics, preventing and reporting all forms of corruption in accordance with our Anti-Bribery and Anti-Corruption Policy and Whistleblower Policy.

We will drive the sustainable use of water in our operations and supply chain through strong governance, risk management and the establishment of objectives, targets and performance monitoring indicators.

18. Encourage innovation, through research and development of sustainable technologies and circular economy processes, establishing alliances and collaborations with other stakeholders.
